

## ADDENDUM A

The following is an amendment to the Area 17 Memorandum of Understanding for Local Workforce Area 17 (MOU) for the agreement period ending June 30, 2023.

For Columbiana County, The Counseling Center, has requested to utilize available office space from MCTA that was vacated by a previous partner.

- A. The Counseling Center will assume 1 FTE on the Cost Share Budget, with no escalation in costs to partners.




